Treasurer's Report Jim Hrabosky reviewed the April Operating, Capital, Restricted and

Federal/State Grant Funds Budget Summaries. Wages/benefits increased \$700,000 as compared to one year ago. We are projected to have a \$1.6-\$1.8 million operating deficit this year which will be covered by federal stimulus funds and fund balance. He also presented enrollment comparison reports for spring and summer 2022 and 2023. The Treasurer's Report was accepted as

State and Federal Activities

-The Governor's budget for 2023-24 includes a two percent increase for community colleges. This equals about \$180,000 for BC3. The Council of Presidents via the PA Commission for Community Colleges is now requesting a seven-eight percent increase which matches other public higher education sectors. Julie forwarded the board an easy-to-use link to a website designed to

help with our advocacy. Please complete it.

-Elizabeth Bolden, is leaving her position as President/CEO of the PA

Commission for Community Colleges, effective July 7, 2023. She has been a

tremendous leader, advocate and friend. We wish her all the best moving forward.

College Activities

- -Dr. Neupauer is pleased to appoint Audray Muscatello Yost to the Preston Park Board of Advisors in his role as President of BC3.
- -Commencement ceremonies begin at 1:00 p.m. today. Butler Mayor, Bob Dandoy, is the keynote speaker.
- -The annual Art/Graphic Design/Facets show was held at BC3 @ Cranberry on May 5.
- -On May 6, Stephan Carlson, Richard Hartung, Bill Miller and Dr. Thomas TenHoeve were inducted into the Charles W. Dunaway Hall of Fame.

Facilities

- Mr. McCafferty reported the committee met on May 15, to discuss the following:
- -BC3 @ Armstrong-A 13-month project schedule was developed and it remained on-schedule through completion. The site was well-received by the Ford City community.
- -Victor K. Phillips Nursing and Allied Health Building-This was an 18-month project and it also remained on-schedule. Furniture has been moved into office spaces and staff are moving in. A value-added change order is being presented to the board today. This has to do with an enhancement to the project we have designed to better acknowledge Mrs. Janice Larrick. The BC3 Education Foundation will pay for this enhancement.
- -STEM Building HVAC Repair-The damage occurred on February 3, 2023. As of today, most of the damaged equipment has been removed. A temporary a/c unit was installed. New equipment has started to arrive.

Motion-Change Order, VKP Nursing and Allied Health Building

Mr. McCafferty moved to approve the following change order for additional general contracting work at the designated outdoor classroom. This proposal was reviewed by the College's architect who indicated the associated cost is in line with current market pricing: R.A. Glancy & Sons, Inc. – Add not to exceed \$25,689.16. -The Foundation made its second million-dollar payment to the College for the VKP Building.
