President's Report Dr. Neupauer reported on the following:

State and Federal Activities

-The Council of Presidents is working on operating and capital requests. Jim

budgeted for a three percent increase.

-The PA Commission for Community Colleges advocated for increased state funding for PA's 15 community colleges in the 2023-24 fiscal year budget. Governor Shapiro proposed a two percent increase in his initial budget proposal; however, a higher percentage increase is needed to properly fund both the operational and capital needs of the community colleges across the state. The Commission developed a tool to make it easy to advocate for

increased funding for Pennsylvania's community colleges. Entering your name

on the web site generated a short letter to your Senator and

Representative, respectfully requesting increased funding for Pennsylvania's

community colleges. Thanks to the trustees that signed the letter.

College Activities

-We are looking at how to deliver Commencement in 2024.

- -Dr. Neupauer attended the Community Colleges of Appalachia conference on June 4-6, in Asheville, NC. He is the board chair of CCA.
- -Drs. Neupauer and Willoughby made a presentation on generational differences at the Strategic Horizon Network colloquium on June 11-13.
- -A BC3 @ Brockway anniversary event, celebrating 10 years of serving the community and five years of educating nursing students, is scheduled for July 28, from 2:00-5:00 p.m. Trustees have been invited. Please RSVP to Julie by July 7.
- -The Kids on Campus program is in full swing. There is much activity on-campus.
- -We are honored to be the recipient of the Sen. Tim Shaffer bequest of \$3 million. It will be the largest gift BC3 has ever received.

Executive

Mr. McDowell reported the committee met on June 8, to review the proposed 2023-24 budget, tuition policy and insurance renewals as well as an extension of the agreement for the lease of BC3 @ Brockway.

Resolution 23-06 Tuition Policy for Academic Year 2023-2024

Mr. McDowell moved to adopt the tuition policy for academic year 2023-2024 as follows:

Butler County residents \$130/credit hour Non-sponsored PA residents \$233/credit hour Out-of-state residents \$333/credit hour

Fees for other services will continue to be set by the Administration. Motion Carried.

Resolution 23-10 BC3 @ Brockway Lease

Mr. McDowell moved to approve modifying and extending an agreement for the terms of the lease of the Brockway facility with GEC Real Estate at Parkside, LP. Motion Carried.

Motion 2023-2024 Insurance Renewals

Mr. McDowell moved to appoint Arthur J. Gallagher of Pittsburgh, PA, Mitchell Insurance, Inc. of Butler, PA, and C.W. Howard Insurance Agency, Inc. of Butler as brokers for insurance coverage as presented, totaling \$256,258. Motion Carried.

Facilities

Mr. Miller reported the committee did not meet. However, he asked Brian Opitz to give a construction update.

-The Victor K. Phillips Nursing and Allied Health Building project began in December 2021 with substantial completion this month. The move-in process

begins in two weeks. Kudos to the College Services staff for planning and scheduling of ordering and delivery of the building's furniture and equipment.

The President is further authorized to grant a one-time \$1,000 payment for Administrators and Professional/Technical Employees earning \$75,000 (2022-2023) or less. Motion Carried.
